After careful examination of the references cited and as per conditions laid down in G.O.Ms.No.1 Edn. Dt: 01.01.1994, the competent authority is here by accorded **Provisional Recognition** for a period of [10] years commencing from the academic year **2012-13 to 2021-22** for classes **I to V (EM)** in respect of **St. Elizabeth Convent (EM) PS, Magdumpally Road, Bhongir**.


1. That the society shall abide by the instructions / rules regulations made by the Govt. or authorized Officer time to time.
2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed from time to time.
4. The School timings vacations and Mid-term holidays shall be as prescribed by Government from time to time.
5. That the qualified staff with in the age limits prescribed by the Govt. for Govt. Employees shall be appointed as per the staff pattern.
6. That the results of Institution shall be satisfactory every year.
7. That the records/accounts shall be furnished to the District Educational Officer every year by 30<sup>th</sup> September at the latest.
8. Governing body may be constituted immediately and that the list of governing body shall be furnished to the District Educational Officer every year.
9. That the pay structure / Fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.Os and other orders, which are not specified in these orders, shall be complied with.
11. That the school shall not be closed without giving notice both to the parents / D.E.O and competent authority at least 6 months before.
12. That the school shall be closed or permission to close only from the date on which summer vacation is declared.
13. That the society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
14. That the School shall be enrolled in DCEB, Nalgonda and following school timings, term holidays like Dasara, Sankranthi and declare 2<sup>nd</sup> Saturday as a holiday strictly.
15. Medical Inspection should be done yearly twice without fail.

The inspecting authority i.e., Dy.E.O. Bhongir, Nalgonda Dist. has submitted the report for provisional recognition to the school for the years 2012-2013 to 2021-2022 vide letter third cited. The Dist.Ednl.Officer Nalgonda Dist. has verified the application for provisional recognition with reference to the inspection report of the Inspecting officer and also with reference to the conditions laid down in the permission order/previous recognition orders and G.O Ms.No.1Edn, (PS.2)Dept, dt.01.01.1994 and submitted a report in his letter 4<sup>th</sup> cited.

After careful examination of the references cited and the conditions prescribed in G.O. Ms. No.1/Edn, (PS.2) Dept, dt.01.01.1994 the Regional Joint Director of School Education, Hyderabad hereby accorded Provisional Recognition to Class(s) VI to X (E.M) for the years 2012-2013 to 2021-2022 in respect of St.Elizabeth Convent (E.M) High School, Bhongir, Nalgonda Dist. subject to fulfillment of conditions as detailed below:

01. That the Educational Society shall abide by the instructions/rules issued by the Govt. from time to time.
02. That the educational Society shall serve the needs of locality more particularly.
03. That the institution shall adopt the curriculum and syllabus prescribed from time to time by the State Government.
04. That the school timings, vacations and mid-term holidays shall be as prescribed by Govt. from time to time.
05. That the qualified staff within age limits prescribed by the Govt. for Government employees shall be appointed as per the staff pattern as per G.O Ms.No. 103 Edn (PS), dt.05-08-2005.
06. That the results shall be satisfactory every year and not to be announce the ranks in SSC Public Examinations as per the G.O Ms.No.49 Edn. (PS), dt.26.02.98.
07. That the records/accounts shall be furnished to the D.E.O every year by 31<sup>st</sup> March, at the latest.
08. That the list of governing body shall be furnished to the DEO every year.
09. That the pay structure / fee structure fixed by the governing body shall be got approved by the DEO every year.
10. That all the conditions prescribed in G.Os and other orders which are not specified in this order shall complied with.
11. That the school shall not be closed without giving notice both the Parents/DEO and competent authority at least (6) months before.

12. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. That the society shall submit proposals for renewal of provisional recognition sufficiently in advance i.e., at least (6) months prior to the date of expiry of the renewal.
14. That additional sections/higher classes should not be opened without prior permission of the competent authority.
15. That the recognition is accorded to society and no other society or body can open a school on their behalf.
16. The recognition is accorded to open the school premises in the locality and there shall not be any change in the premises or locality.
17. The society shall provide, the necessary material even if it costs more than the deposit amount.
18. Admissions should be made on the basis Record sheet issued by the Private Recognised/ZP/Govt/Aided schools only T.Cs/Certificates issued by the Secretary, DCEB as Bona-fied candidate.
19. The Edn.Society shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by Govt. from time to time by the end of April every year as per G.O.6<sup>th</sup> cited.
20. The above E.T.R. is granted subject to condition that, If it is found later that the school has not fulfilled the prerequisite condition under A.P.Edn. Act 1982, reported by State Level Inspection Team and Vigilance Committee, the E.T.R. now being granted is liable to be withdrawn at once.
21. The Management shall provide sufficient transportation, sufficient fire extinguishers in the school.
22. The Management is totally responsible in all aspects for the safety of school children. They will be personally held responsible if any incident occurs.
23. The Management shall handover the school premises whenever required to this department / Government for emergency purpose (Exams/ Elections etc., ) without any deviation of the orders.
24. Subject to the conditions that the Management is instructed to obtained the No objection certificate Fire from Fire Department


